I. The Regular meeting of the Board was called to order at 7:34 p.m. by Mayor Raymond Muniz.

II. APPROVAL OF MINUTES:

A. Trustee Junker moved to suspend the reading of the minutes and approve the minutes from October 04, 2007. Trustee Robards second. Voice vote, 6 ayes, motion carried.B. Trustee Miller moved to accept the agenda. Trustee Meyer second. Voice vote, 6 ayes, motion carried.

III. REPORTS OF COMMITTEES:

A. MAYOR'S REPORT:

1. Mayor Muniz reported that he intends on having OSHA come in and do a presentation for the public works department some time soon.

2. Christmas Kickoff is November 30, 2007. The Lions Club is going to participate this year as well. They are sponsoring a horse and carriage and they are donating all of the Christmas stockings. The Kickoff starts at 6:30 p.m.

3. Mayor Muniz reported that the IML Conference was very informative this year. He would like everyone to consider going next year.

B. COMMUNITY DEVELOPMENT: MEYER

1. Clerk Wildhaber said the website is coming along very well. We are gathering pictures and other items for the website. The Village has hired a photographer for November 8, 2007 at 6:00 to take pictures of current employees and trustees.

C. WATER & SEWER COMMITTEE – MILLER:

1. Trustee Miller explained that the Village board has decided to increase water rates. The increase will be \$0.25 on the minimum and 2% on additional water usage. The sewer rates will be not increase.

Trustee Miller made a motion to approve the water rate ordinance 07-501. Trustee Meyer second. Roll call, all in favor, motion carried.

2. Mayor Muniz reported that the surveying has been completed for the water line extension on Route 4. We should have the plans by the next meeting, so that we can get cost estimates.

D. POLICE COMMITTEE -:

1. Trustee Robards reported that Halloween was good, not very many problems.

2. There was an accident by dew drop today. Also the computer for the car is almost complete.

3. Mayor Muniz reported that Michelle's (our police secretary) husband was diagnosed with cancer. He would like everyone to keep them in their prayers.

1. Trustee Reilson stated that the surveying of the water plant has been completed and hopefully we will have the plans at the next meeting.

G. STREET & ALLEY/MFT - ROBARDS:

1. Trustee Junker reported that the street crew has been cold patching around town. They also have a company coming in to fix the street next to Auto Xtreme. The company is going to asphalt a section of the road. It will cost about \$1500. If this fixes the problem then we will try this on other roads.

2. Trustee Reilson asked why there isn't a 4 way stop by Dew Drop. Mayor Muniz stated that it is a state road and that we have tried for years to get one there but the state won't put one in.

1. Mayor Muniz reported that the October 30, 2007 hearing on the storage units and the car wash was canceled. He stated that the Village Attorney, the Zoning Officer and the Building Inspector discussed the rezoning of the property.
