 They review some ordinances and gave to Building Inspector Keith Frey to follow up on

 \$26,095 for the purchase of a new Police car and that does not include the Police package
 which could be an additional \$3,000 and is still researching all possibilities. Trustee Beil to
 have another committee meeting on March 3, 2015 regarding the Police car.

- 2. Discussion ensued regarding the annual auditor. Trustee Richeson made a motion to hire Kenneth Loy Firm as the annual auditor. Trustee Beil seconds. Roll call vote, all in favor, motion passed.
- 3. Discussion for the 2015 Annual Chamber of Commerce Auction sponsorship. Trustee Richeson made a motion to sponsor the auction at the Grass Skirt Level for \$375 and to spend \$50 on a basket as a donation. Trustee Zahn seconds. Roll call vote, all in favor, motion passed.
