# PRESIDENT AND BOARD OF TRUSTEES THURSDAY, OCTOBER 15, 2015 **REGULAR MEETING MINUTES #15-20**

#### CALL TO ORDER, ROLL CALL AND PLEDGE OF ALLEGIANCE

#### I. APPROVAL OF MINUTES AND AGENDA:

1. Trustee Richeson moved to approve the minute's #15-19 for October 1, 2015. Trustee Howe seconds the motion. Roll call vote, all in favor, motion passed.

1. Jean Sheets states she has a question regarding the culvert at Frey's resident. She asked if the Village was going to remove the short culvert that Mr. Frey placed at his own resident and add a longer culvert that goes across Frey & Frutiger's driveway at the Villages expense.

### IV. HOMECOMING REPORT:

1. Chris McCulley reports the profit of the Homecoming being \$6,586.79 and everything was way down, which she believes was due to the weather. Trustee Gavlick questions the amounts of the 2 page report because they are both different amounts. She states that she doesn't do the report and that Kathy printed them off so we would have to look into it. She asked if anyone knew of someone who would like to join the committee. Chris wants to know what the flexibility would be on the use of grounds if Neumanns lots sold. Mayor Schiefer states that in the past they blocked off roads by the Community Building, which he is aware that the Community Building wouldn't want us to use their property. Chris is meeting with the ride company on Tues. up at the Village Hall. Mayor Schiefer suggested maybe changing the parade route to leave the park going left instead of right. Mayor Schiefer states that he believes that the board will volunteer and help support the Homecoming and states that everyone did a good job this past Homecoming.

A. Joanne Berry with Gateway Business was unable to make it but sent a memo over for Mayor and Trustees stating that we need more time to research other software.

### A. COMMUNITY DEVELOPMENT/HEALTH:

- Trustee Howe read a report that Trustee Beil wrote up since she was unable to attend tonight's meeting. Christmas Party to be at B.S. Boogies on Dec. 12, 2015 at 6 p.m. with dinner and to pay \$60 bar set up fee. Trustee Richeson made a motion to have the Employee Christmas Party at Boogies with the dinner to be around \$20-\$22 per person including tax/gratuity paid out of the Homecoming fund. Trustee Gavlick seconds. Roll call vote, all in favor, motion passed.
- 2. Trustee Gavlick made a motion for Trustee Beil to go ahead and purchase Christmas decorations not to exceed \$3500.00 and to be paid out of the Homecoming Fund. Trustee Richeson seconds. Roll call vote, all in favor, motion passed.
- 3. Trustee Howe read the report from Trustee Beil regarding Christmas in the Village on December 4th, 2015, she would like it to be for the kids and also an open house for any other residents that

would like to attend and have refreshments available. Trustee Gavlick states that in the past we always had plenty of refreshments. The committee proposes the purchase of a new Santa suit. Trustee Richeson made a motion to go ahead and purchase a Santa Suit not to exceed \$200.00 and to be paid for from the Homecoming fund. Trustee Gavlick seconds. Roll call vote, all in favor, motion passed.

4. Trustee Gavlick made a motion to sponsor 5 games at \$20 a game for a total of \$100 to be paid out of the Homecoming fund. Trustee Richeson seconds. Roll call vote, all in favor, motion passed.

Trustee Gavlick would like to table the Golf Cart Ordinance indefinitely.
- 2. Trustee Richeson made a motion for Village employees to receive \$125 and Police Officers/Part Time employees to receive \$75 all after taxes for their Christmas bonus. Trustee Howe seconds. Roll call vote, all in favor, motion passed.
