IV. HOMECOMING REPORT-

Lauren Eilers reported that the profit from the 2017 homecoming was \$15,286.01. She reported that the Triad Booster Club no longer wants to run the food stand for the homecoming. The committee was only 6 people this year and there needs to be more volunteers next year. Mayor Schiefer thanked the committee and stated this year's homecoming was one of the better years.

V. TREASURER REPORT:

Year to date, all funds have revenues exceeding expenditures except MFT. The audit fund is \$5 thousand to the good. This will continue because the auditor's bill is paid and that's the only thing that is paid from that fund. In the IMRF fund, revenues are twice expenditures. This affirms the board's decision to not raise the levy. While the insurance fund has a large balance in it at present there is a bill for \$35 thousand waiting to be paid. For the month of September, revenues exceed expenditures in all funds except water and sewer.

There was a large expenditure in the sewer fund: payment on a skidster. In the water fund there was \$20 thousand spent on radio-read meters.

There were a couple significant expenditures in the general fund/ public grounds subfund. A \$14,800 roof was put on the activity center and there was \$46 thousand in capital outlay for the remodel of it.

The Village's cash balance is \$886 thousand. Trustee Eilers made a motion to accept the Treasurer report. Trustee Richeson seconds. Roll call vote, all in favor, motion passed.

Trustee Ross stated that he thinks we should be able to replace it for the \$6500 that was approved but that doesn't include the electric.
