The fire department would be responsible for all maintenance. Trustee Gavlick questioned a written agreement between the two entities on the matter. Fire Chief Nic Klaus stated they would have their attorney prepare in agreement. Trustee Richeson made a motion to approve the request to mount the antenna on the water tower. Trustee Ashoff seconds. Roll call vote, all in favor, motion passed.
- 2. Audrey Bolk addressed the board about the water bill at 409 Napoleon. There has been a lien placed on the property for a delinquent bill from last December that the tenant moved out and didn't pay. She stated that she called Madison County recorder office and they didn't have a record. The board produced her the attorney invoices and the invoice from the recorder office. Ms. Bulk left the meeting.
