I. APPROVAL OF AGENDA:

- 1. Trustee Richeson made a motion to approve the minutes 22-20 for October 19, 2022. Trustee Ross seconds. Roll call vote, all in favor, motion passed.

1. Chad Rainwater with A & H Mechanical and he runs the electrical division of the company addressed the board. He stated that at the prior meeting comments were said about a past electrical project that he did, and he came tonight to answer any questions regarding the work that was done by the company.

IV. TREASURER: September report to the board

Page 1 Total cash is \$1.4 million and net assets are \$8.3 thousand.

Page 2. For the month of September, there is a surplus of \$3,592 despite the major deficit in the sewer fund and a small one in the Trash fund.

Page 3 The year-to-date surplus is \$2,183.60 despite major deficits in debt service and sewer, a significant one in water and minor ones in social security and trash. Those are balanced out by a major surplus in the general fund and significant ones in audit, IMRF, and MFT.

Page 4 In Ordinance and Finance salary expense is greater than usual because elected officials were paid.

Page 7 In Public Grounds there's a miscellaneous income item for \$23 thousand. It's part if the Rebuild Illinois grant the Village is receiving. The total is estimated to be \$72 thousand. I believe the Board is aware that part of this grant has been received and spent. No decision has been made as to the Village's best use for the funds.

Page 16 The board is aware of the reason behind the large repairs and maintenance in the sewer fund. Trustee Richeson made a motion to approve the Treasurer report for September. Trustee Schmidt seconds. Roll call vote, all in favor, motion passed.

A. COMMUNITY DEVELOPMENT/HEALTH:

1. Trustee Schmidt stated they had a homecoming meeting last night and would like the homecoming to put on the next agenda.

- 1. Trustee Ross stated there is nothing to report regarding the new water tower,
